Membership Memo

Dues Alert! Renew Now!

It's time to renew your membership for 2014–2015. Dues are \$82 (\$49 national, \$15 state, \$18 branch). In addition to personal benefits, your AAUW membership supports our mission: equity for women and girls through education, advocacy, philanthropy and research. Please renew by June 10.

Of the national portion, \$46 of your dues is tax deductible as a charitable contribution for federal income tax purposes.

Membership renewal options:

1. You can renew online with a credit card through the Membership Payment Program (MPP) on the AAUW website. You will receive an immediate confirmation e-mail, which is also sent to the branch treasurer. The first time you log in there are a few extra steps. See below under *How to Use the Membership Payment Program*.

2. You may send an \$82 check payable to AAUW—Fairfax City Branch to **Kelly Espy, 5814 Spruce Grove Ct., Haymarket, VA 20169**. (Life members: \$33.) For your convenience, you may send a separate check for dues with your banquet reservation check to Kelly or you may renew at the May 22 banquet.

How to Use the Membership Payment Program

1. To Log In With Your Member ID

Go to www.aauw.org. At the top of the screen, click on “Login.” Enter your AAUW member ID and password and click “Login.” There are helpful links in case you haven't logged in before or have forgotten your ID number or password. After logging in the first time, the process is much easier. Once you select “Login,” your ID number will be

displayed. Just enter your password and follow the steps below.

2. To Access the Member Services Database (MSD)

Once you have logged in, “Hello, *your name*” will appear on the top line. Scroll to the bottom of the page. Click on Member Tools in the second column. Then, scroll down the Member Tools page to find the Member Services Database link in the left column. Click the “Enter Here” button.

3. To Access Your Personal Membership Record and Renew.

On the Access Member Services Database page, click the “Enter Member Services Database” link to access your record. Find the menu column on the left. Look for “Membership Payment Program” and click on the submenu link ‘Renew My Membership.’ Enter your credit card information.

Before submitting your renewal, consider contributing on the same page to AAUW Funds, the Legal Advocacy Fund, or the Educational Opportunities Fund. Our branch's goal is to contribute \$30 per member toward the funds. Individual contributions (online or by check) designated with the branch ID, VA3042, are credited toward our branch contribution. That leaves more available for our Beverly Anderson Scholarship Fund.

4. **Submit your renewal**, verify your entries, and submit again. When you're done, remember to log out at the top of the renewal page. Look for the confirmation email.

If you have any problems, see the top of the renewal page for the link to the User Guide and for help by email or phone.

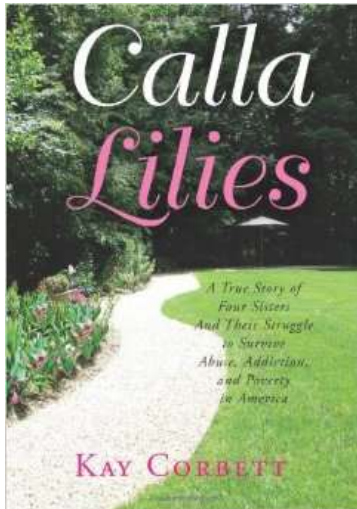


Other reasons to access

Member Profile

Do you know the Fairfax City Branch member who fits this profile? An AAUW member since 1981, she has been active in at least three AAUW

branches. Soon after she joined the Fairfax City Branch, she began her long tenure as chair of Public Policy and the Afternoon Literature interest group. More recently, she served two terms as Program Vice President. She belongs to an ethnically diverse family. If you have been active in our branch for a while, you'll know this valuable member is Renee Prasad.

Sadly, Renee lost many members of her family to the Holocaust including her grandparents. However she remembers vividly her Silesian grandmother. The stately woman had a regal bearing which was enhanced by her long, braided hair worn high atop her head like a crown. In a recent interview Renee recalled her early childhood as a newly arrived immigrant from Germany. The English language was foreign to her then. Unlike today, there was no special assistance in school for children unfamiliar with English.

Renee's degrees in International Affairs at Hunter College and the United Nations Program at New York University are a reflection of her interest in various cultures and world affairs. While living in New York, she met her Indian husband-to-be Pono, who was attracted to her as she modeled a sari.

Years later when she lived in Simsbury, Connecticut, a member of the Indian community introduced Renee to AAUW, and she became a member of the Greater Hartford branch. She then joined the local branch when they lived in Weston, MA. After moving to Fairfax around 1997, she promptly joined the Fairfax City Branch and, to our benefit, became active immediately. In addition to being chairs of Public Policy and Afternoon Literature, she has participated in the Salon and Great Decisions interest groups, arranged for a speaker from the Virginia Gildersleeve International Fund (VGIF), and has frequently volunteered for our various activities.



Renee and Pono have traveled extensively. Pono's career in banking has taken them to interesting and exotic lands. When Pono worked for the New England-Taiwan Business Council, they journeyed to China. They, of course, take countless trips to India. They stay in the New Delhi area and visit Pono's family in the hilly city of Ranchi. Pono comes from a prominent Indian family, many of whom have distinguished themselves in the law. Pono's father was a public prosecutor, one brother was a dashing lawyer and freedom fighter and his youngest brother was a judge. Just a few years ago while traveling through India, Renee visited a VGIF-funded project developed by women to improve women's lives.

Renee is proud of the educational attainment of their children. Their son, a locally practicing anesthesiologist, married a Japanese woman whom he met at Williams College. She is retired from her position as a lawyer with the World Bank. The couple adopted twin girls from mainland China. Now in high school, the twins were schooled through the Japanese immersion program, and can communicate with their Japanese grandparents when they visit Japan. Renee and Pono's daughter, who is employed by British Airways, lives in England.

Recently Renee experienced a bout with cancer. She wants us to know that the chemotherapy was effective, and that she is on the mend. She and Pono will soon move to a new home they recently purchased in the Potomac Green neighborhood of Ashburn, Va. We wish them well and hope to occasionally see Renee.

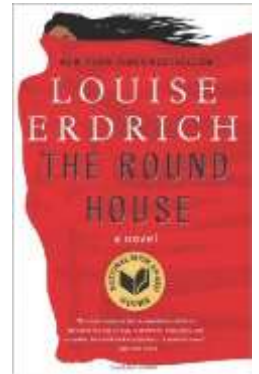
From Clifton: go straight ahead at the Frosty Meadows sign onto the private road and up the hill and follow directions as above.

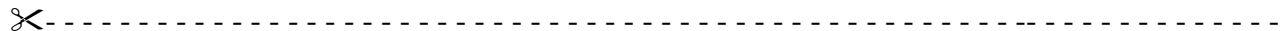
