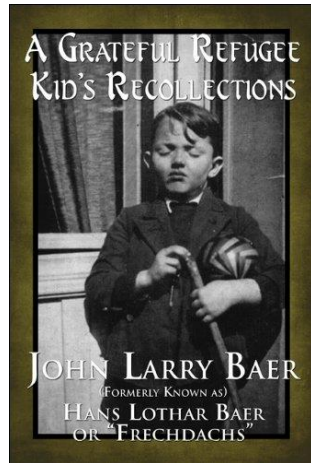

John Baer spent his early childhood in Nazi Germany. He and his cultured Jewish family couldn't have imagined the horrors that were soon to befall them, as the Nazi's brazenly proceeded to take away their comfortable home, belongings, and family members. Their lives were turned into turmoil and sadness. Miraculously, they managed to escape to England and from there to "Amerike."

The travails of a refugee family are told in a wonderful upbeat way by Mr. Baer. The wonderful educational opportunities that his new homeland gives to him are told in an inspirational way. Mr. Baer will delight us with the amazing story of his life. His very title tells you that he has great thankfulness and praise for what America offered to him. The story goes through childhood, immigration, education, and years of work at Aberdeen, Maryland.

Mr. Baer was a chemical and industrial engineer. As such he was involved in many interesting projects for large companies, the U.S. military, and various government projects. After retirement, he had an even more fascinating job as an international consultant. During this time, he returns to Germany, a very changed place, but still finds remnants of his old home and living relatives.

Mr. Baer believes in "giving back." His current list of volunteer efforts will amaze you! Don't be surprised if the next time you are released from a hospital stay, that he'll be there to push



your wheel chair. You don't want to miss this heartwarming story.

### The Gift of Membership

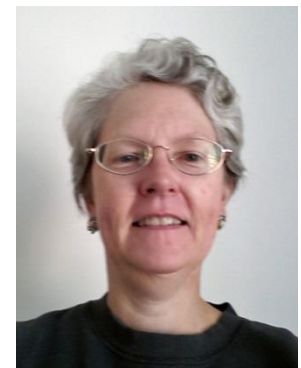

## STEM-tastics Event Scheduled

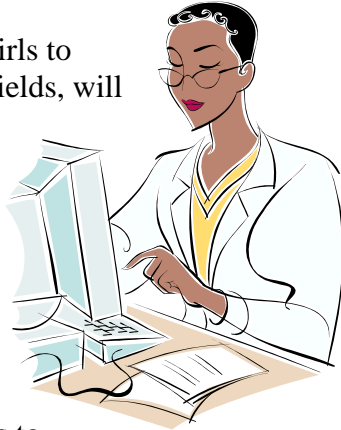
STEM-tastics, inspiring girls to pursue careers in STEM fields, will be held on Saturday, March 8, 2014, at the Annandale campus of the Northern Virginia Community College (NOVA).

STEM-tastics is a career day event designed to inspire middle school girls to pursue careers in STEM fields. Female presenters from across STEM fields will lead hands-on workshops for students and informational workshops for parents. While covering a range of STEM fields, the focus areas will be computer science and traditional engineering fields.

The Fairfax City AAUW branch, along with the Reston Herndon AAUW Branch, will co-chair the event. AAUW members from the McLean branch are assisting with outreach. Other AAUW members from Fairfax County will assist on the day of the event.

We are also partnering with SySTEMic Solutions at NOVA. They are a NOVA innovative regional initiative to build strong bridges between the business community and education and increase the number of students in STEM-related degree or certificate programs. They will support the use of facilities at NOVA along with coordination with NOVA students and the middle school girls.

We hope to have over 250 students and 125 parents from across the county. There will be a charge of \$15 per student; however students on a school lunch program will be exempt. We will



reach out to girls from schools with a predominance of students on the school lunch program. We are also working with Fairfax County Public Schools to reach out directly to parents of middle school girls.

## PETITION: Pass Equal Pay Legislation in Virginia

Dear Virginia General Assembly,

We the undersigned join with the American Association of University Women (AAUW) of Virginia in urging you to pass legislation protecting workers who share salary information with their co-workers.

With a record number of women in the workforce and two-thirds of women functioning as primary or co-bread winners for their families, equal pay for women is critical to families' economic security. **Yet in 2012, women in Virginia working full-time, year round, were still paid 79 cents on average for every dollar paid to men.**

Even worse than the wage gap existing is the reality that few women actually know if they are being paid unfairly, and some don't feel safe asking those questions at work for fear of retaliation from their bosses. They could even be fired!

If we are to help women ensure they are being paid fairly, we have to change this. I urge you to pass legislation protecting workers who share salary information with their co-workers so we can finally enable Virginia women to bring home the pay they have rightfully earned.
